

# Application for an Objection to a Development Contribution under s199 of The Local Government Act 2002

This form should only be used if you wish to object to a Development Contribution (DC) requirement under s199D. This objection must be lodged within 15 working days after the date on which the person received notice from the council of the level of development contribution that the council requires. If an application for reconsideration has been lodged with the council the 15 day time limit on lodging the objection takes effect once the result of the reconsideration is known. The right of objection conferred by this section does not apply to challenges to the content of a development contributions policy prepared in accordance with s102.

Objections are determined by government appointed development contributions commissioner(s) and may be subject to hearing. As the objector, you will need to cover the costs for the objection process. A deposit of \$1,844 is to accompany the lodgement of this objection.
