DECISION

This is an application by Swan Investments Limited for a Temporary Authority Order in respect of premises situated at 13 Tasman Street, Collingwood, known as "Collingwood Tavern".

Reports were received from the Licensing Inspector and the Police and no matters in opposition were raised. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in Section 136 of the Act.

Accordingly we grant an Order authorising the sale and supply of alcohol on the premises situated at **13 Tasman Street, Collingwood** and known as "**Collingwood Tavern**" to any person for consumption on the premises and to let people consume alcohol there, for three months from the date of this decision and authorise the issue of the Order.

The applicant's attention is drawn to s.136 of the Act obliging the holder of the Order to:

1. Ensure that the on-licence remains in force for the term of the Order.
2. Comply with the same duties, obligations and liabilities as required by the current on-licence.
3. Comply with the conditions of the Order.

This Order may issue once the District Licensing Committee Secretary has received evidence of the sale of the Collingwood Tavern to Swan Investments Limited.
