
The general nature of the event to be held is that of a series of One Act plays.

Reports were received from the Licensing Inspector and the Police and no matters in opposition were raised. Accordingly we deal with the matter on the papers.


We are satisfied as to the matters to which we must have regard as set out in Section 136 of the Act.

It is noted that the applicant has little or no experience in the sale of alcohol from "On" licence premises, so it is agreed between the applicant and the Tasman District Licensing Committee that the function of Manager will only be undertaken in "Off" licence premises. This limitation may be reviewed by the Tasman District Licensing Committee and removed as soon as suitable experience is obtained by the applicant.

We grant the application for a renewal of a manager's certificate pursuant to s.228 of the Act. In accordance with Practice Statement LIQ/ADM 1 issued under s.176 of the Act a new certificate will issue which will expire on **22 January 2018** unless again renewed.
