2. Comply with the same duties, obligations and liabilities as required by the current off-licence.
3. Comply with the conditions of the Order.

The application was publicly advertised and there were no objections. Reports were received from the Licensing Inspector, the Police and the Medical Officer of Health and no matters in opposition were raised. Accordingly we deal with the matter on the papers.

The licence will not issue until all relevant clearances have been obtained. The applicant is not entitled to sell alcohol until the licence issues. Unlicensed sales can result in imprisonment for up to three months or a fine of \$40,000 (ss.64, 233 and 234 of the Sale and Supply of Alcohol Act 2012 refer).

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the application accordingly.

The licence will be issued on completion and certification of the building requirements and payment of the Annual Licence fee.
