DECISION

This is a rehearing of an application by Angela Marie Morris for an on-licence in respect of premises situated at 502 High Street, Motueka, known as "Toad Hall". The general nature of the business is that of a restaurant. The application was originally heard at Richmond on 12 December 2013 and a licence was granted for one year (Decision No. 051/ON/22/13).

The application is being reheard as a result of advice received from the Ministry of Justice in relation to the transitional provisions of the Act and the disposal of applications made in the 6 month period immediately following the commencement of the Act.

Initial advice from the Ministry was that any licences issued were to be issued as "temporary" licences that could not be renewed. The Alcohol Regulatory and Licensing Authority has now advised that these temporary licences can be renewed.

An application for a new on-licence was received from Angela Marie Morris by the District Licensing Agency on 8 January 2013 and a "temporary" licence was issued to the applicant on 30 January 2013. Having been advised that this licence could not be renewed, the applicant then made a new on-licence application on 23 October 2013. A new one year licence was issued on 12 December 2013.

It is now apparent that the licence issued in January 2013 could have been renewed for a period of three years. In the interests of fairness and equity, and in order not to unfairly penalise the applicant, it is now proposed to reissue the licence that was granted on 12 December 2013. The licence will expire on 12 December 2016.
