

Notification of Surrender of a Resource Consent (Take and Use of Stored Water)

This notification is given under Section 138 of the Resource Management Act 1991

Background

Until recently a resource consent was needed to take and use water stored in constructed ponds, reservoirs and dams. The Council has now removed this requirement subject to meeting certain conditions (below). This form may be used to surrender an unneeded resource consent.

I confirm the ongoing taking of dam storage for irrigation will fully comply with the conditions of Permitted Activity Rule 31.1.2.1 of the Tasman Resource Management Plan. Specifically that:

1.1 Fish and eels are at all times prevented from entering the reticulation system. This means a screen or screens is installed on the intake that has a screen mesh size not greater than 5 millimetres and is constructed so that the intake velocity at the screen's outer surface is less than 0.3 metres per second and is maintained in good working order at all times.
