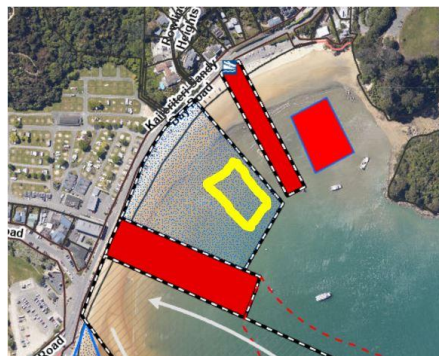
**NAVIGATION SAFETY BYLAW 2024 – Maritime event, Temporary Reservation  
Kaiteriteri Water Park - 17<sup>th</sup> Dec 2024 – 19<sup>th</sup> January 2024**

Thank you for your maritime event notification received on 11th October 2024. Your activity has been approved, and we are pleased to support your activity.

The activity may only occur if it is carried out in accordance with the information in the application and the safety plan provided. This acceptance has been granted in accordance with authority either directly available or delegated to the Harbourmaster by the Tasman District Council Navigation Safety Bylaw 2024 Clause 22.

**The following conditions will apply:**

- 1 Water World Ltd (the “activity organisers”) shall be responsible for ensuring that all conditions imposed by this letter are complied with.
- 2 The activity is to occur between on 17<sup>th</sup> December 2024 until 19<sup>th</sup> January 2024.
- 3 The area referred to above is defined as being Kaiteriteri, at the northern end of the swimming area.



This approval affords exclusive rights to the event organisers of the activity within the highlighted area and for the period specified in (2) and (3). Control of individuals not directly involved in the activity, to restrict their entry to the reserved area is to be undertaken by the event organisers.

- 4 Every person taking place in the activity must wear a correctly fitted life jacket.
- 5 Incidents and near-misses must be reported to the Harbourmaster. This can be done via email or through our Tasman District Council website.

- 6 All anchors must be secured within the swim zone and not outside causing a hazard to nearby or passing vessels.
- 7 Public liability insurance for this activity is due to expire 18/12/24, please forward a copy of the new insurance certificate when it has been issued.
- 8 A copy of this letter will be forwarded the event organiser, commercial vessel operators in the Tasman, and other organisations to raise awareness of the event taking place. This will be available on our Tasman District Council website.

- 9 The activity organiser must remain contactable by the Harbourmaster while the water park is in Kaiteriteri.
- 10 The activity organiser is responsible for ensuring hazards are managed adequately. They have ultimate control of safety during the activity, and shall be responsible for, but not limited to:
  - a) Preventing other maritime vessels, or persons, moving into the event area/pathway during the event taking place.
  - a) Inspecting the area for hazards before/after the activity starts/stops each day.
  - b) Ensuring they can effectively communicate with participants if the activity need to be halted.
- 11 The activity can be stopped by a warranted duty Harbourmaster or Enforcement Officer at any stage if they consider that it is no longer safe for the activity to proceed.

As this is a commercial activity, an application fee applies. An invoice will be forwarded shortly.
