1 PUBLIC FORUM

Chair Maru welcomed everybody to the last meeting of the year and thanked them for their attendance.

2 APOLOGIES AND LEAVE OF ABSENCE

3 PUBLIC FORUM

lan Williamson spoke to the Board about a number of topics. Mr Williamson tabled a copy of his notes.

Jim Butler spoke about his concerns regarding the Tasman District Council rates increases and the proposed Motueka Community Board delegations.

Isobel Mosley, Chair of Keep Motueka Beautiful provided the Board with an update on their projects over the 2018 year with Thorps Bush being a priority. The three areas of focus at Thorps Bush include interpretive signs, planting and fencing. Keep Motueka Beautiful would like to start

planting some grassses in the bare pockets of land at Thorps Bush. In the new year a footpath will be built beginning at Old Wharf Road going along the sea side of the canal. In conjunction with some of the residents on Courtney Street East the swamp area will be planted. Keep Motueka Beautiful would like to be involved in the Motueka High Street beautification project when it begins.

6 PRESENTATIONS

6.1 Dangerous, Insanitary and Affected Buildings Policy

Building Assurance Technical Lead Phil Beck spoke to his report and informed the Board that The Building (Earthquake-prone Buildings) Amendment Act 2016 was introduced on 1 July 2017. The Act requires the Council to review and amend our previous "Earthquake-prone, Dangerous and Insanitary Buildings Policy" dated 2006.

Mr Beck explained to the Board members how Council will identify, assess and take action in respect of any dangerous, insanitary buildings. The policy also confirms that ultimately the responsibility is with the owners to manage and maintain their own buildings.

Mr Beck explained the level of importance placed on ensuring buildings are safe to live in and occupy, Council will take enforcement action to reduce or remove and danger or prevent a building remaining insanitary.

For dangerous buildings the Council may seek the advice of Fire and Emergency New Zealand. For insanitary buildings the Council may request an Environmental Health Officer to assist.

Rule of thumb: for determining an affected building that is "nearby", this will be taken as 1.5 x height of the dangerous building (or part thereof) on level or gently sloping ground. This factor will increase by 'X' for moderate or steeply sloping ground.

Consultation is open until 22 February 2019.

7 REPORTS

7.1 Motueka Community Board Delegations

Community Development Manager, Susan Edwards spoke to the report contained in the agenda which was taken as read.

7.2 Discretionary Fund Applications

Lynne Rosewarne spoke on behalf of Special Olympics Motueka who require funding for some events that are coming up in different areas of the county and will include representatives from the Motueka area. Transport and accommodation are the biggest expenses.

Shirley Frater spoke on behalf of the Senior Citizens Association and asked the Board for financial assistance to remove the leaves from the gutters/spouting, it has become a health and safety issue. Mrs Frater wished the Board season's greetings and thanked the Board for their support.

Dr Jackie Cook spoke on behalf of the Takaka Hill Bio-diversity Group (TH-BG) project to poison and eradicate wasps on the Takaka Hill between the Abel Tasman and Kahurangi National Parks. TH-BG are requesting a 30% percentage of the cost of the project from the Motueka Community Board's discretionary fund. The Board members asked Dr Cook some questions before approving the funding.

7.3 Motueka Community Board Chair's Report

Board Member Hutt spoke to the Board regarding a potentially huge event coming to the area in April 2020 called BRECA. Chair Maru and Mayor Kempthorne agreed to write letters supporting the event coming to our District.

Councillor Hawkes voiced his concern about the lack of speed signs on Thorp Street.

Board Member Horrell expressed to the Board his disgust in the lack of roadside mowing carried out by the Council's contractor.

Mayor Kempthorne informed the Board that he has written a letter to the Hon Phil Twyford and the New Zealand Transport Agency (NZTA), expressing concerns the Council and community have with the 2018 Government Policy Statement on Land Transport (GPS). He noted that the NZTA investment decision making process has resulted in some key priority projects in the Tasman region being excluded from the 2018-21 National Land Transport Programme which include:

- SH60 Motueka Improvements and
- SH60 Richmond to Appleby Safer Corridor

His letter stated, Motueka is a growing community with a busy state highway going through the middle and is the main access road to the Abel Tasman National Park and the Golden Bay area with significant tourist traffic. Mayor Kempthorne explained in his letter that the Motueka community were expecting some action to resolve some of the community frustration with intersections and pedestrian safety issues. Mayor Kempthorne emphasised in his letter the importance of the liveability of Motueka needs greater consideration by the NZTA in its future assessments.

Chair Maru noted that he is waiting for an appointment to discuss this issue with Hon Damien O'Connor.

Chair Maru and the Board discussed the pruning and maintenance of the elm trees on High Street. Chair Maru noted that Council staff are delegated to manage the trees in line with health and safety requirements.

Richard Kempthorne left the meeting on 5.20pm.
