2.1 Quarterly and Harvesting Reports

The Chief Executive noted that the net result for the year's budget is expected to be about \$150,000 to \$200,000 below budget.

Mr Fincham of P F Olsen & Co Ltd said that the price for Douglas Fir is low. He said the expenditure on forestry is being kept low.

3 MOTUEKA AERODROME REPORT – APRIL/MAY 2006

Motueka Aerodrome Manager, Mr R Askew, spoke to his report of 6 May 2006 contained within the agenda. The report raised the situation of drag racing and concurrent airport use, particularly relating to a situation where an aircraft was required to take off on the day the Nelson Drag Racing Association was holding its meeting.

Mr J Gourdie, Nelson Drag Racing Association, was present at the meeting and Cr Bryant asked him to comment on that situation.

Mr Gourdie said the Association is trying to get an integrated, multi-motorsport facility up and running before the end of its consent period finishing December 2008, relating to Motueka Aerodrome. Mr Askew commented on the NIWA lightning detector located at Motueka Aerodrome and said that any alternative location would need 100 metres of free space around it and be located in a secure area.
