9.1 Brightwater Wakefield Flood Modelling, Report REP13-12-04

Policy Planner, Lisa McGlinchey and Glenn Stevens were in attendance to speak to the report contained within the agenda.

The report introduced the flood modelling work undertaken on the flood plains of the Wairoa and Wai-iti Rivers in the vicinity of Brightwater and Wakefield and sought approval for public release of the information.

9.2 Review of Navigation Bylaws, Report REP13-12-03

Harbourmaster, Steve Hainstock and Policy Planner, Maxine Day were in attendance to speak to the report contained within the agenda.

The purpose of the report was to seek approval to begin the special consultative procedure specified in section 83 of the Local Government Act 2002 in relation to repealing the existing Tasman District Council Consolidated Bylaw, Chapter 5: Navigation Safety 2005 (amended 2006) that was made under the Local Government Act 1974, and replacing it with a set of Navigation Bylaws made under new provisions of the Maritime Transport Act 1994, including approval of a related Statement of Proposal (pursuant to s83(1)(b) of the Local Government Act 2002).

- the press release date of Saturday 21 December 2013.

- 4. notes that staff will meet the requirement under section 33M(1) of the Maritime Transport Act 1994 to consult with the Director of Maritime Safety on the draft Navigation Bylaws.
