1 PUBLIC FORUM

1.1 Brent Maru

Mr Maru spoke on behalf of the Tasman Youth Council and advised that they would be holding a youth event at the Skate Park prior to youth week commencing on 24 May 2008.

He expressed concern at the lack of a transport system for the youth and is keen to support a bus service to link Motueka with Richmond Aquatic Centre and the Hub in Nelson.

1.2 Jacqui Taylor – Our Town Motueka

Ms Taylor said she had received negative feedback regarding the poster barrel in front of the museum with regard to posters falling off it and the design. She agreed that poster sites were needed, but more consideration should be given to the structure and siting.

1.3 John Friis – Marahau Residents

Mr Friis spoke about freedom camping signs that have finally been erected, the sand-spit toilets and the possibility of coordinating them into the car-park that was planned. He advised that a working bee is planned for Anzac weekend for planting. He also expressed concern that the lawn mowing around Marahau has only been done twice this year.

1.4 Jim Butler – Grey power

Mr Butler expressed concern regarding overhanging trees and shrubs on several Motueka streets, and about a Motueka resource consent hearing being held in Richmond. He reported that the meeting held between the Imagine Theatre and the Cadets had resulted in an impasse at this stage.

1.5 Bob Cooke – Keep Motueka Beautiful

Mr Cooke reported that Link Road has now been soiled and seeded, the walkway by the Recreation Centre has the ground all ready for planting and a \$10,000 grant has been received from Canterbury Community Trust for extending the walkway from Up the Garden Path to Wharf Road.

Mr Cooke said he was appalled that a Community Board Member objected on television to a business (McDonald's) coming to Motueka, which was a reflection on the Board.
