# **Application for Community Board Funding**

June 2011

This document accompanies the standard form of application for Community Board Discretionary Funds.

## **History of the Motueka Community Gardens**

In winter last year a group of people got together to design and start building the gardens in land in Old Wharf Road (in front of the Inlet Reserve Adopt-a-Plot area) provided by TDC and using a start-up \$5000 funding from Nelson District Health Board.

The first five plots were built in spring, working bees were held twice a week over summer (currently back to one a week), and a bounteous crop was harvested. A Charitable Trust to administer the entity was set up early this year, and there are seven trustees.

Encouraged by the success of the first growing season, the trustees are currently planning a series of steps to expand the gardens' facilities and plots for use by more people and groups, including education on sustainable vegetable growing.

## **Details of this project**

At present many people are not aware of what the area is being developed for. People walking past ask or just wonder. There needs to be a sign and noticeboard which will (a) say what the prepared area is about and (b) allow garden workers to be aware of what specific projects are under way at present, by way of the noticeboard.

The proposed sign will be of a similar design and function to that at the Community House. Quotations have been prepared on that basis, and accompany this application.

## **Who will benefit from the project**

The first harvest now pretty much finished benefited not only the people who worked on it, but also several community organisations which helped distribute produce to people in need, including the marae after the Christchurch earthquake, food banks, and seasonal workers from the Pacific.

This will continue in future, but also we have a strong goal to get more people involved in maintaining communal gardens and private plots, and in particular community groups and schools to help their members to understand better the benefits of self-sufficiency in food.

## **Voluntary time and money contributed:**

Apart from the seeding \$5000 grant (of which just over \$1000 remains and is earmarked for some vital purchases including some tools and garden bed construction), all the time building and maintaining the current plots has been volunteered.
