Good Morning Jim, I am in receipt of your letter and invoices dated 7 Oct

Please note my response is as a Consent holder in Golden and Tasman Bays with a long history of involvement and fairness.

I will not be accepting or signing any interim arrangements. To do so would simply be untenable and extremely high risk for any responsible business owner.

As you are fully aware I along with mu industry colleagues have paid comparable rates to TDC based on the Port Marlborough Model.

I have done so in good faith and without prejudice albeit for a comparably substandard service in terms as far as wharf, cranes and general services are concerned.

Over the last ten years or so I have been involved in a string of the near useless and time wasting meeting's which rate as the worst I have I been subjected to in my 30 year involvement with Mussel Industry Administration and Governance, culminating with the current situation which Council has concocted in order to address historical poor management, and targeting my industry as some form of income generating opportunity to remedy this.

During that period Council has essentially lied to industry about provisions and projects and continued to under perform to the extent all involved are left completely flummoxed and feel at the very least deceived.

Councils proposed model for income generation based on revaluing clapped out assets to New or near new value is verging on extortion. May I remind you have a monopoly and control of the services, you should not be abusing that monopoly

The model developed for the Marine Farming industry and Port Marlborough and shared with you is an honest transparent and ethical model which benefits all parties involved and delivers a return to the shareholders at the same time.

I know in my own business, there is no opportunity for me to take the 21 year old vessel I recently brought for \$200k, revalue it to replacement at around \$1.5m and charge out accordingly. My industry like yours has standard value cost recovery and charge out models. TDC's proposed model is in my view unethical and will result in gouging and abuse of monopoly and control.

The simple solution is to allow Industry to work with Council on a practical level design and build a purpose built facilty which I am confident Industry would sign up for and pay for.

This is why I will not sign up to an open ended "contract". Please refer to page two of Schedule one Annual Fee Structure

I submit that this report is complied from an entirely commercial perspective and ignores the original intent of the port to also be used for recreational purposes. This may be due to, due to misapplying of accountancy practices the port appears to be losing money and therefore requires a general rate subsidy, this is not the case. The port users are currently paying a rate of return derived from Port Tauranga of 7.29% and deprecation on a theoretical port replacement value of approx. \$12m. The actual cost for the port, if it was built at the lowest cost is 2m. This bookkeeping practice is adding over \$5m to the port expenses over a 5 year period. This is not real money until it comes from port users wallets. This is disgraceful;

In the draft plan every section of the port utalised by recreational users is forecast to increase between 80% - 100% yet commercial rates are forecast to increase by 30% - 50%, Recreational users are and will continue to subsidise commercial users, this is madness.

The proposed increase in marina, mooring and ramp fees will result in Port Tarakohe being the most expensive service that has the lowest quality of service in the entire wider region.

The proposal that current grassed reserve land be used for commercial storage is against the original vesting intent, contrary to the reserves act 1977 and contrary to TDC resource management plan, this makes the proposal not only impossible but morally wrong.

Currently Pohahra boat club have a lease that covers the land to the west of the club rooms, to the road and to the harbour walls, it is proposed that Boat Launching trailers be required to park in this area. PBC will not relinquish their right to this land for this purpose.

It is stated in the plan that operationally the simple structure of a full time manager reporting to the property services manager would continue.

I submit that management structure of the port be improved, day to day management of the port should include performance management in strategic, operational and financial aspects of the port operation, it appears there is a strong current focus on financial.

For this performance management process to be effective measurement of these areas needs to be completed in a clear and visible manner, this includes consulting port stake holders on operational needs and sharing operational results of performance.

There is a current focus on measuring performance on complaints received, this is not constructive in either relationship building or improvement of port operations.

It is noted that one of the performance criteria for the current Harbour Manager includes maintaining direct communication links with port users. I contend that this is not happening to the satisfaction of port users. Better information and communication flow from Port management and TDC governance structure to stakeholders would allow positive relationships to be formed to the benefit of the entire operation



We are not at all happy with the draft Development Plan as proposed and wonder why this has to be done in such indecent haste. You have been aware of the problem for many months and it is a complex one that requires a good deal of input from all people affected by this Plan. The idea of moving the floating pontoon down in front of the Boat Club is a poor one for various reasons which have already been covered. Surely what TDC are considering is contravening the original sale agreement between TDC and Golden Bay Cement. Please give this complex matter a lot more thought. This affects the whole of Golden Bay.

To the Tasman District Councillors in regard to their consideration of the "draft Port Tarakohe develpement plan"

The "plan" lacks credibility on several levels and should be put in the waste paper bin.

1)The assumption that council should receive a return on a 12 million dollar asset which has only cost the council less than 3, possible as little as 1.5, if previous consultant fees are removed, would not stand up to any serious accounting scrutiny and borders on being mischievous in its advice. The replacement value *estimate*, is not the value of the asset. The value of the asset to the Tasman District is a mixture of its net income generating ability and its community user value. This is the value that the asset would reach on the "open" market if for sale. The community user value to any prospective buyer would be a financial cost and as such devalue the asset.

The current user fees for the marina reflect the market value for such at the present time, and it should be noted that there are very few facilities provided to it by council as is the case in Nelson for example, such as amenities blocks. It should be noted that these fees provide for more than the actual costs in maintaining and providing for the facility at present.

- 2)Community at large value: the port is a recreational facility on several levels and as such must be viewed in a similar light to sports facilities, such as stadiums, swimming pools etc. It is used by families to fish from, by young and old beginner sailors, by tourists just wandering about. Fees for such are generated in some instances already such as the launching fees and indirectly by the lease agreement with the Pohara Boat Club..
- 3)The commercial wharf! If you cannot tell me how much this facility earns and costs, then we are looking at an incomplete picture. This information has to be available. I urge you in your roles as keepers of the public estate in Tasman, to get this information. How many tons of shell fish, lime, etc go over this wharf each year? Are there fees attached and if so are they higher or lower than a similar port in NZ. What are the costs of maintaining this facility particularly....? We do not know. What we do know is that at the present time the marina occupiers are subsidising it.

#### Summary.

It is important, as the primary keepers of this at present public asset, to recognize in your role, that Port Tarakohe is a multi use facility. It has fully commercial users at one end, the wharf, recreational at the other, and in between there are both recreational and commercial occupiers in the form of the marina complex.

As the district grows, the earning capacity should increase and may more than account for any supposed short fall in revenues currently provided for from the General Rate. Find out absolutely the earning capacity of the commercial wharf. without this information you cannot make any sort of decision, only a guess. Examine the future earning potential: it will be a contributor to the general rate. Lastly, this current draft plan should not only be thrown in the rubbish, it should not be paid for. Let this be clear, the council on our behalf, does not hold an investment of twelve million dollars in the port. It holds an investment of up to three million. To argue a return on the three million could be considered reasonable so long as a significant proportion was returned to the non commercial aspect of the port. To then call this a subsidy from the General Rate would be clearly incorrect.

The decision you make on Port Tarakohe will determine the face of Golden Bay for ever. The present draft plan is nothing short of a recipe for failure as the revenues demanded of it cannot possibly eventuate, unless it can come from the commercial wharf.. something no one, including the author of the draft plan, seems to have the slightest idea about. The result is obvious.. a book keeping financial failure followed by a sale.

I have a boat in the marina and I am very concerned with the fee restructuring being proposed in your plan. I certainly don't mind paying a fair percentage of cost for anything I wish to purchase including marina berthage but the methodology you have used to calculate fair value cost seems incredibly unjust. With the actual cost to the TDC for the port being under 4 million dollars to just chose to revalue it and then adjust cost to port users accordingly seems grossly unfair. How can you possibly consider it reasonable to suggest we became by far the costliest marina in either the top of the south or the bottom of the north when the facilities offered are amongst the worst in terms of ablutions etc mostly because you as a council have found yourselves in the position of having incurred massive debt load for whatever reason. How can you suggest that the increases for the commercial usage would be unsustainable and therefore not apply the full amount to them but think they are sustainable for the recreational users. A lot of the boat in this marina are not of a high value and that would reflect on the financial state of the owners. This is not a rich mans marina!! I suspect that if you pass this proposal on the 5th of December you will be remembered for it for all the wrong reasons for a considerable time. It appears that there is a theme pervading this report that relates to its stated aim of examining the port purely on a economic level. This is at odds with the port being vested in your stewardship for a 50/50 split commercial/recreational and makes the whole thing seem incompletely researched. A local councillor at a recent meeting stated that while the cost of this report was unknown at this stage the consultants had been instructed that the report was not to be expensive. This suggestion in itself should make you as individual councillors question the quality of it. As I am also the Treasurer of the Pohara Boat

Club some of the reports suggestions certainly have me questioning the quality of it. eg The stated intent to move the pontoon to the front of our clubrooms when everyone here in the bay knows it dries out in that area from time to time and at most time has no more than 1 or 2 feet of water over it. It also seems that the authors have missed the point that we as a club hold a lease over the land next to our clubrooms that they suggest relocating the boat parking to from next year. This lease has more than 5 years to run and the TDC has just informed us of their willingness to renegotiate a right of renewal!! Surely this decision cannot be made on the 5th based on this misinformed report.

As the treasurer I would like to take this opportunity to inform you of the effects of your proposal on our finances. By doubling the cost of the ramp cards to us and the public you will effectively drive three quarter of our membership away as they have stated to us that they intend to just use the ramp on a day rate when the weather is to rough to use the Tata ramp. Also by taking away the area we currently use as a pop for selfcontained motorhomes to park boat trailers on would effectively remove the small revenue stream we get from their usage of the facilities we offer them in our laundry. I suspect the combination of these loses will put a unsustainable strain on our reserves over time. I have only been a member of this club since being asked to consider this role just prior to the last AGM and agreeing to as a chance to put something into the community but while researching the minutes to establish our position going forward it has become apparent to me that the membership has taken the last 32 years to fund the clubrooms that we currently have and have only just completed paying the mortgage obtained to do so and so I would ask you on their behalf to reconsider these proposals as in this form they threaten this unbelievable community effort. Please at least postpone the decision until we can all be clear on the facts surrounding the validity of this revaluation of the port and the fairness and indeed legality of its usage in determining an appropriate return on the asset for the council. I would be more than happy to present to you in person if you wished it. Thank you for your consideration of these points **Grant Gaby**


