Kia ora

We refer to your official information request dated 7 November 2024. Our response is below:

- 1. Can you provide the following information?
 - a. Details of rules/policies/objectives in your district plan designed to avoid adverse effects of dog attacks and vehicle strike on penguins (specifically hoiho and kororā).

Vehicles on beaches are regulated through a rule in the **Tasman Resource** Management Plan (TRMP). Rule 25.2.2.1 permits vehicles on beaches subject to a number of conditions that must be met:

25.2.2 Passage on Foreshore

25.2.2.1 Permitted Activities (Passage on Foreshore)

The passage of craft or vehicles across or along the foreshore is a permitted activity that may be undertaken without a resource consent, if it complies with the following conditions:

- The activity does not contravene any other applicable rule of Chapter 25 of this Plan. (a)
- (b) In relation to the launching and retrieval of any craft, the most direct route is taken between any launching ramp and water.
- In relation to any craft or vehicle, including any motorcycle, land yacht, or hovercraft: (c)
 - there is no damage to the foreshore or seabed or to animal or plant habitats; (i)
 - (ii) there is no mooring, beaching, or other continued occupation of the foreshore or seabed by the craft or vehicle.
- (d) There is no vehicle or craft passage across any foreshore within any estuary at all times that that foreshore is exposed to the air, except where the passage is for or in connection with:
 - (i) any lawful structure, occupation or disturbance; or
 - any scientific research or coastal management activity.

This includes a condition (condition (c)(i) that there is no damage to animals.

b. Decision making materials that underpin the making of the district plan (including any plan changes) where the need to give effect to the New Zealand Coastal Policy Statement (NZCPS) was considered.

We have commenced a review of the Tasman Resource Management Plan (TRMP), and as part of that review, we will give effect to the New Zealand

Coastal Policy Statement 2010 (NZCPS).

Currently, the drafting of the new plan has been paused until the current legislative uncertainty is resolved; however, in the background, work continues in identifying species and mapping areas within the district needing protection under policy 11 of the New Zealand Coastal Policy Statement. It is anticipated that it will be a few years before this project is completed and decisions made. We have commissioned two other major projects under the NZCPS, which will give effect to Policies 1,13, and 15 (Coastal Environment line, natural character and landscape). These reports are still drafts but can be found here. It is anticipated that the new provisions for this work will be approved by the Council and publicly notified next year.

c. Details of any bylaws or other local measures that protect penguins from dog attacks or vehicle strike.

Please find **a link to** the current <u>Dog control Bylaw 2014</u>. This bylaw provides for protection of local Penguins at Little Kaiteriteri. We also publish information on our website informing the public on permitted and prohibited dog exercise areas - <u>Exercising your dog | Tasman District Council</u>

Council are deliberating on the new Dog Control bylaw this week, and then a decision will be made around the adoption of the new bylaw, more information can be found via the following links: https://shape.tasman.govt.nz/dog-bylaw-review

Council is also installing signage around Kaiteriteri roads advising of penguins.

d. Details of council monitoring of penguin populations and documents that contain monitoring results (including published reports under s35(2A) RMA).

We are not aware of any little penguin/kororā monitoring projects having been commissioned by Council. Surveys of the bird values of Tasman are publicly available for viewing on our website - Environmental monitoring reports | Tasman District Council.

These surveys typically focus on 'shorebirds' and so penguins are only recorded from consultation with local experts

We are aware of a number of surveys that have been conducted by external parties. Key contacts for these are <u>Little penguins in Golden Bay</u>, and the Tasman Bay Little Blue Penguins <u>Love our Little Blues</u>

You may be interested in the Dog Control Activity Report 2023-2024 which is publicly available on our website - Dog Control Activity Report 2023 - 2024 Tasman District Council. However, the reports don't explicitly speak to dog attacks on penguins as this is not a field required by DIA so wasn't reported on.

f. Details of any other actions taken by the Council to protect penguins.

We have in recent months had Permanent Warning Signs of Penguins installed on roads around the Kaiteriteri area to inform motorists. The planning work for these signs was undertaken in the last financial year however, due to funding constraints, the work was deferred until the current financial year.

This work was initiated from Penguin kills that were recorded by Linda Jenkins the local coordinator for Tasman Bay Blue Penguin Trust.

at Tapu Bay.

It was called in to the DOC duty ranger in Picton (Colin) at the time by

whose terrier attacked the little penguin. The dog was being exercised off leash and, as I understand it, pulled the penguin out of a

small cave at the western end of the beach.

I was contacted by a resident, who had been on the beach and who provided a box for the penguin to be kept safe. I uplifted from Tapu Bay around 1030 and transferred to wildlife vet however it died of its injuries mid afternoon. While I was on the beach the DOC duty ranger phoned back so I was able to advise him of the proposed course of action which he agreed with.

It was a low grade white flippered penguin. Conservation status: at

risk/declining.

The dog owner, who lives in accepted full responsibility for the

incident.
