Water Shortage Direction

Section 329 of the Resource Management Act 1991

The Tasman District Council considers there is a serious temporary shortage of water in the following zones and the taking/use of water is to be restricted.

Restricted use is necessary to help prevent further reductions in river flow and reduce the risk of seawater intrusion into the aquifer. Affected consent holders are being advised in writing.

Domestic water use

Domestic water use within any water management zone during periods of water rationing in that zone is restricted:

No watering of lawns or decorative gardens is permitted.

Stock drinking water is not restricted.

A Cease Take (New) shall take effect for all consented water takes (but excludes takes from storage) from Monday 4 March 2019 in the following water management zone:

Motupiko,

A Cease Take (Continues) shall remain in effect for all consented surface water takes (but excludes takes from storage) up to and from Monday 4 March 2019 in the following water management zone:

Moutere Surface Water Zone, Rainey River, Powely Creek, Dovedale

(Dovedale cease take for irrigation of pasture and crop)

Stage 1 Rationing (Continues) which is a 20% cut from authorised weekly usage will remain in effect up to and from Monday 4 March 2019 for the holders of consents to take water from the following water management zones:

Moutere Eastern Groundwater, Moutere Western Ground Water

Stage 2 Rationing (Continues) which is a 35% cut from authorised weekly usage will start from Monday 4 March 2019 for the holders of consents to take water from the following water management zones:

Aorere West Coast, Takaka Aquifer, Takaka Surface, Takaka Marble Aquifer Recharge Zone, Baton, Stanley Brook, Tadmor, Tapawera, Glen Rae

Note: Those consent holders with specific conditions requiring restrictions or cease take are required to comply with the terms of their consent

Stage 2 rationing (Continues) which is a 35% cut from authorised weekly usage continues up to and from Monday 4 March 2019 for the holders of consents to take water from the following zones in the Waimea Plains

Waimea Hope Minor, Waimea Lower Confined, Wai-iti, Wai-iti Dam Service Zone, Wangapeka

Stage 4 Rationing (Continues) which is a 65% cut from authorised weekly usage starts from Monday 4 March 2019 for the holders of consents to take water from the following zones:

Upper Catchments, Reservoir, Waimea West, Golden Hills, Delta, and Upper Confined Aquifer

A conserve water notice is in force and No surface water takes are permitted in the following urban areas:

Richmond, Mapua, Ruby Bay, Brightwater, Wakefield and Hope, and their rural extensions.

The position will be reviewed at the next meeting of the Dry Weather Taskforce on 4 March 2019.
