May it please the Commissioners

1. On 31 January 2025, the further information requested by the Commissioners was supplied to Council.
2. The further report of Mr Gareth Oddy stated (on page 5) that additional sediment analyses had been scheduled, and (on page 9) that: -


"... an updated report will be provided once the final results have been received and addressed".

3. On 5 February the Commissioners, through Mr Doole, asked for confirmation that: -

"... it is the applicant's intention to provide an updated report from Mr Oddy, and if so, when can they expect that to be provided?"

with a response before 11 February 2025.

4. Counsel advises: -
 - (i) yes, it is proposed that on receipt of the laboratory report, Mr Oddy will provide an updated report, incorporating the results of the analysis; and
 - (ii) that Hill Labs have advised (email attached) that "*all going well*" the laboratory results should be available Wednesday (12th of February).
5. On that basis, (and assuming there are no further delays in supply of results from the laboratory) Mr Oddy advises that he could have his updated report available by 5pm on Friday 14 February 2025.

Good morning Gareth,

I hate to be the bearer of bad news! Unfortunately, the earliest the lab can get these results is Wednesday, all going well. Note from the lab below.

"The <63um samples take a long time to dry due to all of the water used in the prep. We cannot extract the OCpT until the sample is dry. With Thursday being a holiday, we can't extract trace samples in one day so we cannot extract them on a Fri as they need an overnight GPC so we will not be able to extract this job until next week now. If they are dry this week we can extract them on Monday next week, run on GPC Monday night, finish extraction on Tuesday, run on instrument Tuesday night and all going well, results on Wednesday"

My apologies, the lab have pushed these samples through as urgently as they could however, having a mid-week public holiday has thrown a spanner in the works.

Apologies again for the inconvenience.
