

## PUBLIC FORUM SPIEL FOR 18.6.19 by Jim Butler

For what it is worth Mr Chairman, this grumpy old ratepayer fully supports the Board's proposal 'Alternative to Golden Bay's Local Board Application' as set down on pages 39 and 40 in your agenda. When I sent in my alternative proposal to the Golden Bay Application to the Local Government Commission (I wasn't going to miss a chance like this) I wasn't certain if the Board was going to send in a proposal, or which way you were going to jump. So. as I suspect that the Board is wiser that me, I set down that I would support whatever you proposed.

While a Local Board appears attractive and I supported Golden Bay having one as a trial, I had doubts about a Local Board for Motueka because of the likelyhood of increasing bureaucracy, overheads and additional costs to be borne by grumpy old ratepayers. So I took this opportunitity to set down what happened to my section and to me when Roger Douglas sacked half the bureaucrats in Wellingon. Also repeated my guessimate pitch on overheads which probably applicable to most councils and central government as well. How \$50,000 of work can end up costing ratepayers (or taxpayers) about\$400,000.

"A contractor gets \$100,000 to carry out a work. The council's costs for arranging and inspection of the work including overheads is also \$100,000, total \$200,000. The council funds this through a 20 year loan which will cost ratepayers \$400,000. But the contractor has overheads too and needs to make a profit. So the end result is that it can cost ratepayers about \$400,000 to get about \$50,000 of work completed." Frightening isn't it.
