Good morning and congratulations to our Mayor and to the newly elected and reelected Councillors. Thank you for the opportunity to come along and speak to you all today.

MOHUA BLUE PENGUIN TRUST PRESENTATION:

I am the Chair of the Mohua Blue Penguin Charitable Trust. Our primary goal is to protect the little blue penguins of Golden Bay.

During the period of the current dog control bylaw twenty-nine little blue penguins have been killed in dog attacks. The death of these twenty-nine penguins took place during the nesting season. For every penguin we lose, we also lose their two chicks. This is because the remaining adult is unable to feed them and will abandon the nest. This equates to a loss of eight-seven penguins under our existing dog control bylaw. The magnitude of a loss like this is unsustainable for our kororā population. Dog attacks on kororā must stop.

Last year the Trust commissioned the Kaikoura Ocean Research Institute to conduct a penguin survey throughout Golden Bay. It was undertaken by the Penguin Detection Team Alastair Judkins and his penguin locating dog Mena. Alastair's report stated that roaming and/or out of control dogs were seen on nearly all the beaches he surveyed. He described seeing a burrow that had been recently dug up and destroyed by a dog.

We have many school children in Golden Bay who love penguins. All five of our schools are involved in a conservation programme building penguin nesting boxes. You will see in their art work these children know that uncontrolled dogs on our beaches attack and kill penguins.

We believe that the magnitude of the slaughter of penguins by dogs in Golden Bay is unprecedented in New Zealand. This is because during the nesting season dogs are allowed off leash on all of our beaches. Tasman District Council has a dog control bylaw but it doesn't actually control dogs. It fails to protect our penguins. They are being slaughtered.

FOREST AND BIRD GOLDEN BAY BRANCH PRESENTATION:

I am going to change hats now and talk about shorebirds. I am speaking on behalf of the Golden Bay branch of Forest and Bird.

In terms of shorebirds Golden Bay has something very special. The number, the variety and the rarity of these birds is something to behold. We have birds that fly here non-stop from Alaska, birds that fly here to feed and rest after breeding in other parts of the country and birds that choose to make Golden Bay home. We birders refer to them as

on the beach.

international migrants, national migrants and resident birds. Up to fifty thousand shorebirds call Golden Bay home in summer.

New evidence shows that 80% of our shorebirds are threatened with extinction. The negative impact of dogs on our shorebirds in Golden Bay is well documented in multiple studies commissioned by Tasman District Council. Off leash dogs harass, injure and kill shorebirds. Dogs roam freely off leash in our estuaries – Wainui, Tata, Motupipi, Rototai, Waitapu, Onehau, Parapara, Pakawau and Puponga.

Forest and Bird continually receive complaints from the public about dogs disturbing shorebirds at roosting sites, dogs chasing birds as they feed on the mudflats and dogs walking through nesting areas. When migratory shorebirds are forced to fly they use up their fat reserves reducing their chance of survival. When dogs disturb resident birds, it reduces their breeding success. This contributes to their risk of extinction. Shorebirds need to be able to feed, sleep and raise their chicks undisturbed by dogs.

The NZ Coastal Policy Statement requires Council to avoid the adverse effects dogs have on our shorebirds and to protect habitats important to migratory species. As signatories to the Ramsar Convention we are obliged to meet our international obligation to protect birds in their migratory stopovers. The Dog Control Bylaw 2014 fails to address the legal obligations of the NZ Coastal Policy Statement and meet our obligations under Ramsar.

Nowhere in Golden Bay are dog owners required to put their dog on a lead. As a consequence, dogs injure, endanger and cause distress to our shorebirds. With no resident compliance officer it is extremely difficult to bring a prosecution against a dog owner. We need more compliance in Golden Bay. What we have is inadequate.

I would like to summarise by saying that both the Mohua Blue Penguin Charitable Trust and the Golden Bay branch of Forest and Bird have support for an early review of the dog control bylaw from Manawhenua Ki Mohua, the Department of Conservation and Science Advisor to the Mohua Blue Penguin Trust Professor John Cockrem of Massey University. Both Professor Cockrem and the Takaka Manager of the Department of Conservation Dave Winterburn have written letters of support for an early review of the bylaw to Tasman District Council.

It's clear that the current dog control bylaw fails to protect our penguins and our shorebirds. We need a new bylaw that enables infringement notices to be issued, a bylaw that has leash control areas to protect feeding birds, a bylaw that prohibits dogs at roosting sites and nesting sites.

TINY homes – or small, functional houses – are being assessed to provide affordable housing for the thousands of homeless and rough sleepers on the Mornington Peninsula.

The homes, which could be set in small villages, are seen as ideal crisis accommodation, particularly for the 135 Capel Caravan Park residents soon to be seeking a roof over their heads after their planned eviction later this year.

The tiny homes could be trucked onto small parcels of land in semi-rural locations or unused public land, such as disused road reserves.

So great is their capacity to offer a practical solution to homelessness that they will be featured in a Tiny Homes Expo on the southern peninsula next Easter.

In the meantime, former Liberal candidate for Nepean Russell Joseph, in consultation with Capel Caravan Park resident Wayne Iremonger, has launched the not-for-profit Peninsula Community Housing to raise awareness of the urgent need for low-cost housing.

The issue was highlighted by the murder of rough sleeper Courtney Herron, 25, in Melbourne's Royal Park last month, Mr Iremonger said. He reflected that her death could have been prevented if she and her attacker had homes to live in rather than foraging for shelter in open parks.

"There are fewer opportunities for low-income families and we need to find and develop low-cost land to house them," Mr Joseph said.

"We are trying to figure out what structure [PCH] should be and how best to raise money for it."

An eco-village using the tiny homes is a favoured option for the estimated 2000 rough sleepers sheltering from the elements on the southern peninsula's beaches and car parks each night.

"Many are women, often older single women with little superannuation, or mums and dads with children – they are our priority," Mr Joseph said.

"We also want to help ageing parent/carers, particularly those with intellectually disabled children. They are terribly worried about theirs and their children's futures.

"We urgently need land and buildings from any level of government or private donors.

"The Salvation Army is desperate for any accommodation. Whatever we build they will fill them. We don't care where the money comes from. There's a lot of frustration building, particularly with the inaction from the state government."

Mr Iremonger said eco-villages would be cheaper than caravan parks and rooming houses, with rents capped at \$150 a week.

"While rudimentary, they will allow for a dignified life for residents as both crisis housing and transitional housing [on the way] to a more permanent solution," he said.

Mr Iremonger said medium and large sites being assessed were the grounds of an old Lutheran Church in Widdop Avenue, Rosebud, and the VicRoads freeway reserve on Boneo Road, Boneo.

Nepean MP Chris Brayne said homelessness was an "important issue that has been facing our peninsula for decades".

"The issue is particularly difficult on the peninsula as finding appropriate land to be used for affordable rental properties remains challenging.

"The 2019-20 Victorian budget delivers on a promise to build 1000 new homes over the next three years. I will continue to fight to see the peninsula get its fair share of public housing."
