7 REPORTS

7.1 Footpath and Pedestrian Improvements Motueka

The Board took the report as read. Chair Maru welcomed Senior Road Engineer Steve Elkington to the table.

Mr Elkington informed the Board that the project to replace the kerb and channel on Boyce street has started. The Fearon Street residents have been advised that reconstruction of the path and kerb and channel will follow on from Boyce Street. The kerb and channel replacement and reconstruction of the footpath on Tudor Street will start after this.

Mr Elkington said a programme of sump upgrades at various locations in Motueka including a new soak pit on Thomason Avenue is currently being priced.

Cr Ogilvie queried Poole Street’s position in the low cost low risk matrix, Mr Elkington said there are currently two options being considered for a pedestrian improvement and the preferred

option is to install a speed table. Mr Elkington suggested the Board make a contribution to this project from their special project fund.

Cr Canton asked Mr Elkington if the 51% of funding assistance from New Zealand Transport Agency (NZTA) would be available for a causeway bridge on Wharf Road for cyclists.

Board member Hutt said there is a petition circulating for a pedestrian crossing on Tudor Street. Mr Elkington explained to the Board that Tudor Street due to its width and pedestrians having a long crossing distance as well intersection turning traffic to contend with and believes a pedestrian refuge would be a better option as this would halve the crossing distance and allow pedestrians to focus on crossing one lane at a time rather than to have to judge all traffic lanes and turning traffic to assess a safe time to cross.

Cr Ogilvie and Cr Canton both thanked Steve for the work he has done and for his collaboration with the Motueka Community Board.

7.2 Motueka Community Board Chair's Report

The Board acknowledged Mr Jim Butlers contribution to the Motueka community.

The Board discussed Tiny Houses and what restrictions they have under the Resource Management Act and the Building Code. The Board requested that Council staff attend a future meeting to provide more clarification on these issues.

Board member Horrell mentioned the derelict sheds on King Edward Street owned by Wakatu Estate and asked the Board secretary to note it in the minutes for the sheds to be monitored by the Board.

Board member Hutt asked the Board to support a notified resource consent application made by Nelson Drag Racing Association, to continue to host four drag racing events over a 10 year period at the Motueka Aerodrome. Chair Maru invited Community Development Manager Susan Edwards to the table and she explained that if a Board member or Councillor were to pass a recommendation now to support a notified resource consent application that would preclude those members from making a decision around the Council table in the future. She noted that the Board has an advocacy role and this it could make a submission on behalf of its community to the resource consent application, if the members wanted to.
